Highlands Bankshares, Inc. Announces Year to Date 2026 Results

Highlands Bankshares, Inc. (OTC: HBSI) announces results of operations through June 30, 2026.

Highlands Bankshares, Inc., the parent company of Highlands Bank and Capon Valley Bank, posted year to date 2026 earnings of \$3,837,000 or \$2.91 per share of common stock outstanding (EPS), compared to \$2,808,000 or \$2.12 EPS for the same period of 2025.

On July 14, 2026, the Board of Directors declared a quarterly dividend to shareholders of \$0.48 per share. The dividend was payable to all shareholders of record as of July 27, 2026, and was paid on or about July 31, 2026. Based upon the current market price and annualizing the dividends paid to shareholders this quarter, Highlands' current dividend yield is 3.96%

Return on average assets (ROAA) increased in 2026 to 1.18%, as compared to 0.92% in the same period of 2025. The return on average equity (ROAE) increased to 11.02% at June 30, 2026, as compared to 8.79% at June 30, 2025.

Total assets, as of June 30, 2026, increased \$17,454,000 to \$649,250,000 compared to December 31, 2025. Total liabilities increased \$15,457,000 as of June 30, 2026, to \$579,611,000 compared to December 31, 2025 as a result of deposit growth.

Shareholders' Equity at June 30, 2026, was \$69,639,000 or \$52.84 per outstanding share, compared to December 31, 2025 of \$67,642,000 or \$51.27 per outstanding share.

Jack H. Walters, Chairman and Chief Executive Officer of the holding company, stated, "We are pleased to present the 2nd quarter 2026 results showing an increase in year-to-date net income of \$1,209,000 driven primarily to an increase in net interest income. As evidenced by loan and asset growth, our local economy continues to remain resilient despite increased energy costs and geo-political uncertainty. Due to our strong performance, we are also pleased to increase the quarterly dividend from \$.47/share to \$.48/share reflecting our success thus far in 2026. The Board's decision to increase our quarterly dividend reflects the strength of our capital position, the consistency of our earnings performance, and our confidence in the long-term outlook for the company."

Highlands Bankshares, Inc. currently operates thirteen banking locations in West Virginia and Virginia through its two wholly owned subsidiary banks, Highlands Bank and Capon Valley Bank, and offers insurance services through its wholly owned subsidiary HBI Life Insurance Company. Highlands Bank will be opening their new Falling Waters West Virginia branch in early 2027.
